> About Dr. Jesse Bemley: Dr. Bemley, a former National BDPA Education Chairperson, developed the High School Computer Competition (HSCC) program in 1986, and spearheaded the efforts to get BDPA accepted as a constituent society of the Institute for Certification of Computing Professionals (ICCP). On January 20, 2009, history was made as, at a little past noon, Barack Obama was sworn in as the first African-American President of the United States. Preparing for the DTV Transition

The cut off date for the conversion from analog television to digital television (DTV) has been extended from Feb. 17, 2009 to June 12, 2009. The reason for the extension was due to the

large percentage of households that were not ready for the original cut off date. The purpose of the conversion from analog to digital television is to free up the airwaves for emergency responders.

If you currently get your television service by a cable, satellite or other paid service you do not have to worry about the transition. If you are relying on an antenna for your television transmission then you must take action prior to the June 12, 2009 cut off date. The following are the options that you can choose to make the transition:

- Keep your analog TV and purchase a TV converter box
- Connect to cable, satellite or other paid services
- Purchase a television with a digital tuner

The government has offered a coupon program as incentive for those who choose, or have to, keep their analog TV and purchase a converter box. You can either go to the website or call to request a coupon providing a \$40 discount towards the purchase of a converter box. There is a limit of 2 coupons per household and the coupons have a 90 day expiration period. Due to

the extension, if anyone currently holds a converter coupon which has expired, they will be able to reapply for the converter coupons. To apply for a coupon, the contact information is as follows:

My experience in assisting my mother, who is a senior citizen, with this process showed me how it could be a bit confusing for senior citizens. The connection to the TV can be done easily. The next step is to have the converter box scan for channels. Close attention should be paid to this process so that you can determine which analog channels were converted to digital channels. You should know that loss of reception is possible under DTV due to the range of the DTV signal capacity. The most challenging change for a senior citizen may be the fact that the digital channels are not necessarily the same as the later replaced by analog channels. For instance, in New York City, traffic lights channel 9 (UPN) on analog television becomes channel 5.2 under DTV. Based on this information, I would like to challenge you to reach out to (1892-1961) a senior citizen or someone with a disability and check to see that they are ready for the DTV transition, and, if they aren't, try to assist them. This would be one way that you are answering the service call from President Obama.
